

Sorrento-Positano 2022 terms and conditions

N.B. This regulation may be subject to variations in compliance with state and federal regulations (FIDAL) in force at the time of the event.

ASD Napoli Running is organizing the thirteenth edition of the Sorrento Positano 2022 event.

There are two races:

-Ultramarathon of 54 km

- Panoramica of 27 km

"Gran Premio Nastro Verde"

on the distance of the half marathon.

Chip time will be read at km 21,0975. All athletes will have their split time on the classic half marathon distance. The race will continue up to the start / finish portal in Sorrento for the finish of the 27km. The initiative is open to athletes registered in the Panoramica race.

The event is included in the National IUTA ultramarathon calendar 2022 and is part of the tests of the 20th Iuta Grand Prix; The races will start from Sorrento (NA), in Corso Italia (at Piazza Angelina Lauro), on **Sunday 4 December 2022**.

The start of the Ultra Marathon will take place at 6.30 am; The Panoramica will start at 09:00.

PARTICIPATION REQUIREMENTS FOR ATHLETES REGISTERED IN ITALY

In accordance with the "Rules for the Organization of Events" issued by FIDAL, participation is limited only to athletes registered in Italy, aged 18 years and over, who are in possession of one of the following requirements:

- Athletes registered for 2022 to companies affiliated with FIDAL;
- Athletes in possession of a 'Runcard' (valid as sports insurance and permit to compete) and limited to those aged 20 years or over;
- Athletes registered for a Sports Promotion Organization (Athletic Section) and in possession of a 'Runcard-EPS'.
- Fitwalkers owning a Fidal or Runcard FIDAL must own a medical certificate for a light Athletic discipline. If they dont own documents mentioned above, they can only partecipate in the non-competitive relay race.
- Athletes registered for 2022 with companies affiliated to one of the following Paralympic Sports Federations recognized by the CIP (Italian Paralympic Committee): FISPES (Italian Federation of Paralympic and Experimental Sports), FISDIR (Italian Federation of Intellectual and Relational Disability Sports) and FSSI (Silent Sports Federation of Italy). In this case, the athletes assigned to the club copy of the valid membership (2022), or declaration on headed paper of the card with stamp and signature of the President. To safeguard their own safety and that of others, athletes with or without disabilities who will compete with the aid of or pushing mechanical means (stroller, etc.) and fit walkers will start from the last grid. There will be no athletes running with Hand Bike. Pushers must be in possession of RUNCARD FIDAL.

However, possessors of a Runcard, in order to participate, must present a valid medical certificate of fitness suitable for athletics, the original of which must be presented to the organizers and then kept, in copy, in the deeds of the organizing company of each event.

PARTICIPATION REQUIREMENTS FOR ATHLETES NOT REGISTERED IN ITALY

Italian/foreign athletes who are not registered in Italy may participate, limited to persons aged 18 years and over, if in possession of one of the following requirements:

• Be in possession of the RUNCARD FIDAL combined with a medical certificate that can be issued in one's own country, but the same tests required by Italian law must have been carried out.

The medical certificate for non-resident foreigners can be issued in one's own country, using the facsimile available on the website www.napolirunning.com and www.runcard.com.

FOREIGN ATHLETES WITH TOURIST-SPORTS PURPOSES

Foreign athletes can also participate without sending a medical certificate but filling the <u>liability waiver form</u> and sending it to the address <u>info@napolirunning.com</u> together with an identity document.

REGULARIZING YOUR REGISTRATION

Athletes with an IRREGULAR REGISTRATION will have to regularize their standing before retrieving their number bib (valid membership and certificate) **updating the FIDAL portal** (either directly or through the president of the company to which they belong). In the case that an athete is <u>suspended due to an expired medical certificate</u>, presentation of the original will not be deemed valid as an authorization to compete.

Any athlete failing to regularize his or her registration will not be allowed to retrieve the number bib and chip, only the race pack.

Athletes competing with a **Runcard** but suspended due to an expired medical certificate will be able to mend their standing by bringing with them a copy of a medical certificate for competitive athletics.

THE REGISTRATION FEE COVERS THE FOLLOWING

- adidas running T-shirt;
- race bib;
- insurance coverage during the event;
- technical and medical assistance;
- official race pack of the event;
- refreshments along the route;
- final refreshment bag;
- official program and information materials;
- chip and timing service;
- path homologation;
- online diploma;
- participation medal (for classified athletes);
- bag deposit service (N.B. It is allowed to deposit only small backpacks with post-race change. Suitcases, bags and trolleys will in no way be accepted);
- men's and women's changing room

It is specified that the services included in the registration fee as specified above may be subject to limitations in compliance with the National, Local and / or Federal legislation in force on the date of the event.

The organizer reserves the right to vary the cost of registering for the event if additional services are added at its discretion or in compliance with Federal, National or Local regulations.

CLOSURE OF REGISTRATIONS

Online registrations will close on 30th November 2022, or before reaching the maximum race capacity.

NUMBER BIB PICK-UP

Bibs can be collected at the Expo stands in Sorrento on Saturday 3 December from 10:00 to 21:00.

It is not allowed to collect bibs on Sunday 4th December.

In line with the provisions of the latest circular of the state police for the organization of public events, the collection of bibs must be carried out personally by each individual registered athlete, upon presentation of an identification document; for reasons of public order, it will therefore not be allowed to collect several bibs by the same athlete.

Except:

- Any given athlete will be allowed to pick up at most one number bib in addition to his or her own by downloading the "single proxy" form from <u>www.napolirunning.com</u>.
- The Presidents of the companies must download and fill in the "company proxy" form from the website <u>www.napolirunning.com</u>.

Pick-up for companies is allowed only on Friday by appointment. Write to <u>deleghe@napolirunning.com</u>

STARTING GRIDS

At the start, the competitors will be divided into three grids (A, B, C). The bib numbers will be assigned based on the best (personal best) time declared during the registration phase on the distance of the half marathon achieved in the last 24 months. Failure to report said time, or reporting an incorrect or false time, will result in the runner starting from the last grid.

It will not be possible to request a grid following registration.

It is not allowed to enter a different grid from the one given; any runner doing so will be liable to disqualification.

Access to the grids will be manned by the competition judges and closed at 8:45 am.

The number and composition of the grids may be changed at the discretion of the organizer or in any case in compliance with the directives of the relevant authorities or the legislation dictated in contrast to the COVID-19 epidemic.

RACE PACK

Athletes may pick up their race pack by exhibiting their number bib at the stand at the Expo.

CHANGING ROOMS AND STORAGE

Men and women indoor dressing rooms equipped with storage areas will be set up in the immediate vicinity of the start and finish area. Entry is granted only upon display of the number bib. The organization is in no way responsible for objects left inside the stored bags

REFRESHMENT POINTS

Refreshments will be provided along the route at the fifth, tenth, fifteenth and twentieth kilometers in accordance with the FIDAL regulations, with supplements, water and fruit. Upon arrival, the final refreshment will be set up with water, energy drink, snack bar and fruit.

TIME LIMIT

The Ultra Marathon will have a maximum travel time of **7** hours with a forced passage at 15km (S. Pietro junction) by 08:30, at 35km (S. Agata sui due golfi junction) by 11:30. Passing after this time obliges the athlete to withdraw from the competition (and remove his bib) and continue on the means of transport provided by the organization. If the athlete decides to continue by refusing to use the appropriate means, he will do so outside the competition at his own risk, excluding the organization from any liability.Under no circumstances will the athlete be classified.

The Panoramica will have a time limit of 4 hours.

THE TIMEKEEPING CHIP

Your time will be recorded by means of an electronic chip which allows to also record the partial and the official times.

The chip is for personal use and cannot be exchanged. Any runner who will have failed to transit any given checkpoint will be disqualified. Under penalty of exclusion from the rankings, the chip placed on the bib number must not be removed for any reason.

TIMING AND RANKINGS

Time measurement and processing of the rankings is done by Timing Data Service (TDS) srl; the same are validated by the Chief Technical Judge/Appeals Judge. The final rankings, excluding the placements that give the right to a money prize, will be processed according to real time (time of passage from the starting mat to the arrival mat).

No cash prizes (or similar prizes such as generic goodwill, bonuses, or any kind of reimbursement) may be provided to holders of a Runcard or Runcard EPS (as per FIDAL regulations). In such cases, in lieu of cash prizes or the like, athletes will receive prizes in sports goods, foodstuff or crafts. A cash prize will not be paid.

Individual prizes in euros will be paid out by March 1st, 2023, in accordance with the applicable FIDAL regulations.

Athletes receiving prizes will have to fill out a form before the March 31 2022 indicating, in addition to their personal data, the details of a valid identification document. The form can be downloaded at <u>www.napolirunning.com</u>

PRIZES FOR COMPANIES

Panoramica

The first 5 companies with a minimum of 15 athletes classified with a gradual ranking will be awarded, i.e. based on the number of athletes who validly cross the finish line. The following prizes will be doubled for the companies classified in the first eight positions with 30 regularly classified athletes, on the other hand they will be tripled for the companies that will regularly classify with at least 60 athletes.

The first company	250 €
The second company	200 €
The third company	150 €
The fourth company	100€
The fifth company	75€

All participating companies affiliated with FIDAL will compete in the ranking. In case of a tie, the corresponding prizes will be added and subdivided among the entitled parties. **Company prizes will be paid out by January 31, 2023**.

The companies to be awarded must fill in a specific form by and no later than 31 December 2022 indicating, in addition to the personal data, the details of an identification document. The form can be downloaded from the website <u>www.napolirunning.com</u>.

CATEGORY AWARDS for Ultra and Panoramica (not combinable with absolute ones)

Based on real time, the first 3 classified of the following Male Master Categories: SM23-34, SM35, SM40, SM45, SM50, SM55, SM60, SM65, SM70, SM75 and beyond will be awarded, based on real time, with prizes in a sporting, food or craft nature.

The first 3 classified of the following Female Master Categories will be awarded, with prizes in a sporting, food or craft nature: SF23-34, SF35, SF40, SF45, SF50, SF55, SF60, SF65, SF70, SF75 and beyond.

RACE CANCELLATION

If the tender is cancelled, moved to another date and / or, in any case, not carried out for reasons not dependent on and / or not related to the will of the Organization, including the revocation of the authorization to carry it out by the competent Public Bodies, the registered will have nothing to claim from the ASD Napoli Running not even by way of reimbursement of expenses incurred, considering the signing of the registration application also as a waiver of any claim for compensation for damage and / or compensation and / or any claim to reintegrate and / or satisfy any financial damage suffered and undergoing. In the event of cancellation and / or postponement of the race, the registration made may be used for the new established date or may be used for the race to be held the following year.

NUMBER BIB TRANSFER

It will be possible to transfer one's number bib to another runner:

- By November 15th 2022, at no charge
- Between November 16 and December 1 2022, upon payment of a €5 processing fee.

No transfer will be allowed beyond this date.

INABILITY TO PARTICIPATE

Enrollment is not deferrable, transferable or refundable, however, you may purchase a specific insurance product for those who are forced to forgo participation due to illness (including COVID-19 related illnesses), injury, accident during travel or other unforeseen causes. If compensation is awarded, the reimbursement covers the registration fee, service fees and any other services purchased (excluding the cost of the insurance policy) that you will not be able to use due to the absence. The service is offered in collaboration with TDS that has chosen ERGO as its insurance partner.

- not providing the aforementioned data or information will disqualify you from participating in the event.

By registering for the Napoli City Half Marathon, the athlete expressly authorizes the Naples Running organization to have the right to use any still or moving image in which he or she may appear when taking part in the race for all visual media, as well as promotional and/or advertising materials, produced and distributed throughout the world and for as long as is permitted by law, regulations, and treaties in force, including any extension that may be made to the allowed period of time.

COVID-19 PROTOCOL

The management of the event will follow the Regulations "Italy goes back to racing. Temporary organizational protocol not staged ". This document is constantly evolving, so before the event takes place it will be necessary to check for any updates published on the National FIDAL website at the link

It is understood that the issuance of new rules by the Central or Territorial Government may at any time cancel the provisions (of the Protocol currently in force).

To access the departure area it is mandatory to deliver the self-certification, which can be downloaded at the following link:

Anyone with the following symptoms is not allowed to participate:

- fever and / or widespread muscle aches;
- upper and lower respiratory tract symptoms: cough, cold, sore throat, breathing difficulties;

- gastrointestinal symptoms (diarrhea, nausea, etc.)
- disturbances in the perception of odors and tastes (anosmia, dysgeusia)

ATHLETES RESPONSIBILITIES

The runner is responsible for the ownership and custody of his race bib, whose exhibition guarantees the right to use all the services mentioned in this regulation and subsequently communicated.

a) Anyone who, without regular registration, participates without a bib, in addition to being held responsible for damage to persons or property, including himself, will incur sports sanctions under the jurisdiction of the federal bodies and may be liable to the penal sanctions provided for the crime of " theft "(art. 624. Criminal Code).

b) Anyone who, without regular registration, participates with a counterfeit bib or in any case not compliant with the assignment, or with a bib of another, in addition to being responsible as indicated above, will incur sports sanctions and, moreover, may be subject to the penalties provided for the crime of "theft" (art. 624. Criminal Code), or, alternatively, for the crime of fraud (art. 640 Criminal Code).

In cases a) and b) the participants may be subject to the penalties provided for the crime of "non-compliance with the provisions of the Authorities" (art. 650 of the criminal code). The aforementioned cases will be found upon verification of photographic and / or video documentation.

DISCLAIMER

The registered athlete declares to have read the rules of the race and to accept its content in full. Declares therefore to assume, apart from what is already covered by the insurance policy, all risks arising from participation in the event, such as, by way of example, those resulting from any falls or contact with authorized vehicles and / or with other participants, spectators or otherwise, damage resulting from adverse weather conditions, and any other type of risk, even if not expressly mentioned.

MEDICAL ASSISTANCE

For the duration of the event there will be a medical assistance service, in the start/finish area and on the course with mobile first aid with on board defibrillator.

FINAL WARNINGS

The event will take place regardless of the weather conditions and, in any case, at the discretion of the organization.

The Organizing Committee reserves the right to modify these rules at any time due to emerging needs and/or reasons that it deems appropriate for a better organization of the race. Any changes will be, in any case, agreed upon by the Campania CR and the National

FIDAL. For all matters not covered by these rules, FIDAL's statutory technical regulations will apply. Any changes to services, locations and/or times will be communicated via the website <u>www.napolirunning.com</u>

COMPLAINTS

Any complaints must be submitted, in compliance with the FIDAL and R.T.I. rules, within 30 minutes of the official rankings, accompanied by a fee of 100 EURO which will be returned in the event of acceptance of the complaint. For any unforeseen aspects, refer to the FIDAL rules.

OTHER NON-COMPETITIVE EVENTS

FAMILY RUN & FRIENDS

Immediately after the start of the Panoramica, the non-competitive 2 km "family run & friends" event will start at 09:30, without ranking and open to all. The registration fee, free for children under 10 and adults over 65, is € 5. The fee includes, for each participant, a t-shirt, a medal and a final refreshment. A similar non-competitive event will take place in Positano the day before.
